

Pursuant to Article 3, paragraph 4 of the Law on Payment Transactions (“FRY Official Gazette”, Nos. 3/2002 and 5/2003 and “RS Official Gazette”, Nos. 43/2004 and 62/2006) and for the purpose of implementing Section 4 of the Decision on the Unique Structure for Identification and Classification of Accounts and Plan of Accounts for the Performance of Payment Transactions with a Bank (“RS Official Gazette”, No. 57/2004), the Governor of the National Bank of Serbia hereby issues

**DECISION  
ON THE ASSIGNMENT OF UNIQUE BANK IDENTIFICATION NUMBERS FOR  
PERFORMING PAYMENT TRANSACTIONS**

1. The National Bank of Serbia hereby assigns to banks the following fixed numbers (three numeric positions) to be used as their unique identification numbers in the performance of payment transactions in the country:

2. Fixed unique account identification number of the REPUBLIC OF SERBIA shall be 840.

Fixed unique account identification number of the NATIONAL BANK OF SERBIA shall be 908.

3. Unique identification numbers specified hereunder shall be used when opening accounts for the purpose of performing payment transactions in accordance with the Law on Payment Transactions and pursuant regulations.

4. This decision shall supersede Decision on the Assignment of Unique Bank Identification Numbers for Performing Payment Transactions (G. No. 6352 of 4 August 2008).

5. This decision shall have immediate effect.
